RAISING OF CLANWILLIAM DAM AND ASSOCIATED REALIGNMENT OF AFFECTED ROADS IN THE CLANWILLIAM AREA: EIA Process

Our correspondence of May 2006 informing you of a delay to the environmental process has reference. This letter is to inform you that the Department of Water Affairs and Forestry (the DWAF) has received approval from the Department of Environmental Affairs and Development Planning (D:EA&DP) in September 2006 to continue with the next phase of the assessment process.

The Current Status of the Raising of Clanwilliam Dam

We have been contacted by several members of the public who reported rumours that the decision had been taken to raise the dam and that work would commence shortly. This is <u>not</u> true. The Feasibility Study, which is being undertaken concurrently with the environmental assessment, will be completed in early 2007 and only then will the DWAF have sufficient technical and cost information to consider this decision. It should be noted however that the dam safety construction work, to strengthen of the wall, will be undertaken by or before 2010, irrespective of whether or not the wall is raised. The work to ensure that the dam wall meets the dam safety requirements and the decision whether or not to raise the dam should not be confused.

Programme for finalisation of the Environmental Assessment

The DWAF now has approval to continue with the Environmental Impact Report (EIR) and the team will be finalising the specialist studies and preparing the draft EIR during the final months of 2006. It is therefore anticipated that the draft EIR will be made available to the public for comment from January 2007 and a public meeting will be hosted in Clanwilliam in late January/ early February 2007. We will provide you with an Executive Summary of the Report and the details of the public meeting as soon as they are available.

As previously noted in project documents and at the public meetings, included in the authorisation processes required by the raising of the dam is an application for permission in terms of the Mineral and Petroleum Resources Development Act (No 28 of 2002) to extend an existing quarry near the Clanwilliam Dam Wall (on the western side of the N7), in order to provide the necessary construction material for the dam raising. An opportunity to comment on the proposed application for the quarry will be provided to the public during the same period in January. After this, the document will be updated as appropriate before being submitted to the Department of Mineral and Energy (DME) for consideration.
